

TORONTO ISLAND CANOE CLUB, 2020 COVID-19 PROTOCOLS

- Only members in good standing may access the Club. Club access is limited to the front lobby, the front washroom and the boat bay. Only one (1) member may be in the Club at one time. The main room, kitchen, change rooms, rear washroom and Camp storage area are closed and off limits to members. Locker rentals will not be offered this season. Members are to empty their lockers on their first Club visit, and the locker areas will then be off limits.
- Member access to the Club is strictly for the purpose of retrieving and returning one's boat, board and paddle. All entry visits shall be as short as possible in duration.
- A hand sanitizing station will be set up in the front lobby. Sanitary wipes will also be provided. All members are required to wipe down all contact surfaces (door keypad, door handles, light switches, washroom surfaces, sign-in area etc.) at the beginning and end of every Club visit. Members are responsible for providing their own masks and gloves. Masks are required to be worn while inside the Club.
- Paddlers should arrive wearing their paddling clothes as change rooms will not be available.
- Members are not to touch any equipment belonging to other members.
- Equipment is not to be shared between members.
- Club equipment (boats, paddles PFDs etc.) is not to be used.
- Guest passes will not be offered this season.
- Members are required to monitor their own health and complete a self-assessment prior to each visit. Members are expected to stay at home if they are exhibiting any COVID-19 symptoms, feeling unwell, have travelled outside Ontario during the past 14 days or have had close contact with a confirmed case of COVID-19. Members awaiting COVID-19 test results are not permitted to attend the Club.
- Members must practice physical distancing; staying a minimum of 2 meters apart from others at all times, unless household members. This requirement is enforceable under Provincial regulations.
- Waivers, as provided by CKC, must be signed before any paddling activities take place.

- Failure to comply with any of these protocols may result in Club membership being suspended or revoked. Refunds will not be issued for memberships suspended or revoked.
